Mr. Jon Grissom of the local NAACP has been asked to determine if Eugene Forte would be considered, by NAACP's definition, a racist.

The NAACP has been provided the Los Banos City Council meeting video of Gene Forte's infamous "N' Word Speech" and his writings in the Badger.

Forte is asking that the NAACP publicly reprimand Mayor Tommy Jones, a public official, for stating that he knew for a fact that Forte was a dangerous member of a racist group - the KKK.

THE FIRST BIG LIE



The first big lie (half truth) that the Los Banos Enterprise reported was that Eugene Forte "suffered a minor injury to his neck" while being arrested. The article of July

24th, 2009, "Man arrested after courthouse confrontation" included an old arrest photo.

Journalistic standards requires disclosure that it used an old arrest photo, *especially when the new booking photo contradicts information in their story.*

The reason for the newspaper's failure to be truthful may lie in the fact that Forte, a Los Banos resident and ex-candidate for Governor of California, has a lawsuit in federal court against McClatchy Newspapers, owner of the Los Banos Enterprise.

The lawsuit claims that McClatchy Newspapers worked with government officials to defame Forte in their efforts to cover up corruption. Yes, Forte claims they are in bed together.

And yes, Forte suffered an injury to his neck, but how he got it and what it

was caused by is the real predicament for Merced County Deputy John Picinich, Los Banos Police Officer Anthony Parker, and California Highway Patrolman Peggy Melden to name only a few at this time.

The actual arrest photo taken on July 21st, 2009 (below left and front page) at the LB Police Department shows a significant contusion to Forte's right frontal lobe, and bleeding from the left ear area.



Forte says that Picinich grabbed the back of his neck and unexpectedly and forcefully slammed his head into a solid wood door

while Forte was handcuffed behind his back.

The impact, Forte says, buckled him to his knees. "Picinich then pulled me back up by my handcuffs while kneeling me in my left side and slamming my head against the wall repeatedly as he pushed me towards the room at the end of the hall," says Forte.

Picinich had arrested Forte previously at the Merced County Courthouse on February 24th, 2009 for double felony counts of obstructing justice, not allowing witnesses in and out of a courtroom, and lunging at a judge.

Merced County District Attorney Larry Morse says that he has a conflict of interest due to his being a defendant in the lawsuit of Tetra Tech Inc. vs. Marion Santos in the Forte cross complainant.

There have not yet been any charges brought against Forte, and surveillance tapes are MIA at this time. Forte says that.....

WAIT, WAIT, HOLD THE BADGERS

Hi! Gene here! Look, I was trying to write in the third person as to what in the hell took place down at the courthouse. I just can't do it.

The story is about me, I'm not an uninterested talking head, or a reporter under the control of publishers that are up the butts of powerful government officials. This is real life.

Picinich is the same jerk who had assaulted me before in February, 2009, when I asked him to put an attorney, Mr. James Padron, under citizen's arrest for me in Merced.

The February incident took place at what is called a case management conference (which is different than a trial) that I was attempting to attend at the Merced County Courthouse.

That case involves Marion Santos and I against Tetra Tech, a billion dollar remediation firm, the Merced County Department Environmental Health, and the Merced County District Attorney's Office.



"Merced County Public Officials tried to muscle me," says Mr. Marion Santos, owner of Los Banos Chevron, and Toscano RV in Los Banos.

McClatchy Newspapers should have reported upon the case because it is of significant public interest. Basically, Santos, the number one payer of City sales taxes, said that he was being bled of hundreds of thousands of dollars by Merced County Officials in cahoots with his own attorneys and Tetra Tech.

The staff reporters (Pride, Lieb, Yancey?) at the Los Banos Enterprise/McClatchy Newspapers have failed to tell you of the fact that the entire Merced County bench took the very unusual action of disqualifying itself from the case without giving a clear reason why.

If you take into consideration that the Merced County bench also did such with the *Forte vs. Tommy Jones* case and put it into a mathematical equation, the common denominator is GENE FORTE.

Picinich attacked me in the presence of other law enforcement officers from the LBPD, the California Highway Patrol and his own Merced County Sheriff's Department. The claims are filed and lawsuits are coming. THE END
