Re: Request for the Arrest/Prosecution of Anthony Donaldson Bates for the Violation of Penal Code 422

Dear Mr. Turner:

I write this letter after our conversation of today at the courthouse wherein you told me, my wife and Ms. Barbara O'Neill that Penal Code 422 only applied to threats made in the presence of the person being threatened by the person doing the threatening. It is abundantly clear from the reading of PC 422 that you are grossly incorrect.

Prior to contacting the Los Banos Police Department, I contacted criminal attorneys who informed me after reading the threats issued to me by Mr. Anthony Donaldson Bates who made them "out of respect and love for my teacher, mayor, and close family friend Tommy Jones" provided that *in their legal opinion* they had no doubt that it was a clear violation of Penal Code 422. I will also say that Ms. Barbara O'Neill upon reading the threats said that she knew of a person that was convicted of a felony for a threat that was far less menacing than the one issued by Bates to me.

I have underlined and bolded the sections of the PC 422 that indicate that your interpretation of the code is wholly incorrect.

## CALIFORNIA CODES PENAL CODE SECTION 422-422.4

422. Any person who willfully threatens to commit a crime which will result in death or great bodily injury to another person, with the specific intent that the statement, made verbally, in writing, or by means of an electronic communication device, is to be taken as a threat, even if there is no intent of actually carrying it out, which, on its face and under the circumstances in which it is made, is so unequivocal, unconditional, immediate, and specific as to convey to the person threatened, a gravity of purpose and an immediate prospect of execution of the threat, and thereby causes that person reasonably to be in sustained fear for his or her own safety or for his or her immediate family's safety, shall be punished by imprisonment in the county jail not to exceed one year, or by imprisonment in the state prison.

For the purposes of this section, "immediate family" means any spouse, whether by marriage or not, parent, child, any person related by consanguinity or affinity within the second degree, or any other person who regularly resides in the household, or who, within the prior six months, regularly resided in the household.

"Electronic communication device" includes, but is not limited to, telephones, cellular telephones, computers, video recorders, fax machines, or pagers. "Electronic communication" has the same meaning as the term defined in Subsection 12 of Section 2510 of Title 18 of the United States Code.

As you can clearly see from PC 422, there is no provision saying that the threat must be done in the presence of the person threatened. An honest reading of PC 422 indicates quite the opposite, i.e. **in writing, or by means of an electronic communication device.**

My family and I are presently and reasonably in greater fear for our safety now than when the threats were first issued due to the inaction of the LBPD Department which I assert in my Grand Jury complaint is in fact orchestrating a cover-up for Mayor Jones. Anthony Donaldson Bates is a loose canon waiting to go off who now feels empowered by the retaliatory prosecution of me and no doubt with his close family friend and benefactor of the threats Jones boasting that he has an injunction against me when I tried to hold him accountable.

You will find attached the faxes I sent to the Los Banos Police Department on February 24<sup>th</sup>, 2010 clearly indicating that I wanted charges brought against Bates for violation of PC 422. You will also find attached the narrative supplement by Detective Townsley which intentionally misstates my request saying that I had requested Bates be charged with a 653(m) misdemeanor. I never said such. I never had conversations with Townsley, and I never told any LBPD officer to charge Bates with a PC 653(m). Townsley, after concocting this lie with Commander Brizzee (now Chief), then released Bates back to the custodial care of the Los Banos High School. Bluntly, that is the way that the cover-up was orchestrated by the LBPD and requires that you order an investigation of the investigation conducted by the LBPD.

Therefore, I am formally again demanding that you arrest Anthony Donaldson Bates for what is a clear violation of PC 422 and **based upon the fact that he confessed to sending the death threats.** I also request that you investigate the link between Mayor Tommy Jones as the benefactor of the threat made by a juvenile under his custodial care at the Los Banos High School. My family and I are citizens and are due equal protection under the laws. If the arrest is not made, and charges are not filed, it is clear that we are being denied such rights due to the vindictive nature of District Attorney Larry Morse who is your boss and who wants to keep us in fear for our lives.

I request that you confirm to me by speaking with DA Larry Morse that he had informed me and my wife on July 31<sup>st</sup>, 2009, that your offices could not investigate any charges against me, or file any charges against me due to his being sued by me in the case of Tetra Tech vs. Marion Santos. Please confirm with DA Morse that he informed me that his actions would be considered unethical, retaliatory, and vindictive. You informed me today that you were not "one" of "all his prosecutors" in the DA's offices that DA Morse said agreed with him that there was a clear conflict.

Please respond in writing to me no later than June 16<sup>th</sup>, 2010 that you have arrested Mr. Bates for my families' protection and that charges are being filed. Until Bates is arrested, our family continues to be in fear for our lives and safety. Both my wife and I are in fear that our daughter who begins high school this year will be in danger from students who may have been friends of Bates and who now feel empowered due to us not being provided equal protection under the law.

You are putting our lives in danger due to political powers that wish to drive us from Los Banos. It is unconscionable and illegal. I will not relent on this matter until we have been provided equal protection under the law for my family's safety. I seriously do not think anyone would blame me or criticize me for the position that my wife and I have taken.

Re: Demand for Immediate Arrest of Anthony Donaldson

Dear Los Banos Police Department:

I contacted you this afternoon immediately after I received credible threats of physical violence from a person by the name of Mr. Anthony Donaldson of Los Banos, California and provided you copies of emails printed off directly from my computer in the presence of Officer Paul Llanez and at his request at approximately 6:30PM or thereabouts.

I then requested that Mr. Donaldson be arrested for my protection. At approximately 8:00PM or there about I contacted your offices to inquire of the status of the arrest and was told that an officer would call me back.

I then received a phone call from Officer Bowling who said they were trying to locate Mr. Donaldson to discuss the matter of the emails with him. I told Officer Bowling they could discuss the matter with him all they want provided that Donaldson be put under arrest.

Officer Bowling said they were having difficulty in locating an address for Mr. Donaldson. I suggested he immediately contact Mayor Jones based upon the information in the emails where Donaldson states:

“Mr. Forte you are lucky I was not at this meeting because out of respect and love for my teacher, mayor, and close family friend Tommy Jones...”

I also told Officer Bowling that I found that Donaldson appeared to play for the Los Banos Tigers and that he could contact the football coach Gary Carapreso. I believe that his number is #23

I then later called back and left a message for Officer Bowling that I also did an internet search from the information in Donaldson’s email and found that his teacher was Ms. April Latta .

It is now 9:01PM and I have not been informed yet as promised by Officer Bowling that when he had Mr. Donaldson in custody he would give me a call, which leads me to believe that incredibly Mr. Donaldson has not been arrested yet.

The admitted and promised to be assailant who in his own words said that he would cause me so much injury that I would never be able to speak again is still at large. Outrageous and not providing me equal protection under the law.

It is tormenting and I physically feel my chest muscles tightening as they did prior to my heart attack in having to think my family are being submitted to this denial of protection under the law.

It is now 9:12PM, please respond immediately confirming that you have obtained Donaldson's address location from Mayor Jones or Ms. Latta, or whomever, and that Mr. Donaldson had been arrested.
