Mr. Forte: First question I want to ask and lets make sure that we watch that timer Mr. Jones. Is that you made a letter of apology the last time I was here I was forced out of the meeting by our now ex-chief Gallagher under threat of arrest. Glad to see we got rid of that bad apple now we still got a few left Mr. Raft and our bailiffs ought to go ahead and be made aware of this. I have had it beyond limits, First question I am gonna ask you is you apologized in a letter to me for cutting my minutes short are you willing right now to grant me an additional five minutes on top of this five minutes for what you did before. Yes or No?

If you want to take a break to discuss this with the council lets do it and stop that timer right now while you give me that answer please? Mr. Vaughn?

Mr. Vaughn: Proceed on with your five minutes.

Mr. Forte: Excuse me I want to know are you going to go ahead and give me an additional five minutes now? Yes or No?

Crowd Member: NO

Mr. Forte: *Addressing the Crowd – You don't have anything to do with it folks. That's Norm Donovan back there or whoever is back there. I don't need to talk to the audience I am talking to this man right here..(Points to Mayor Jones) Do I get the additional five minutes that you cut short before? Yes or No Sir?

Mr. Vaughn: He is going to allow you your five minutes you have for tonight.

Mr. Forte: And not the additional five minutes he cut short that's a subject of a lawsuit but lets go ahead and run to a flyer that's being distributed and I want to go ahead and direct you there's a somebody else standing alongside of me at this podium right now his name is Dr. Carl A. Galloway an African American Physician, my brother that died in my arms in April of 2009 any of these

people here who are not closed eyed will see that I am part of a black family from New York they are my brothers they say that I was probably a black man in a previous life and they killed me then and if I was a black man in this life they would have killed me already. Mr. Jones when I pick up the paper and I see that Mr. Cory Pride another African American over there that goes in and starts yelling racism at individuals then you have Mr. Joe Souza, Hey Joe nice conduct outrageous Sir. When you throw the race card at somebody you better be ready to back it up because you Mr. Jones at the deposition transcripts which Mr. Vaughn sat at and the depositions that were taken are on CD about the lawsuit that I have against you not the City of Los Banos for saying that I that you knew for a fact that I was a dangerous member of the Ku Klux Klan and you said that to Mr. Clinton E. Galloway another African American my best friend for 40 years my best man at my wedding and he signed a declaration stating you said that. Now what you say is that as a black man now you say that another black man is lying, why? Cause he has a white guy as a friend? Let me tell you Mr. Jones what I'm going to ask this officer over here kindly Sir (Pointing to Bailiff), is that after the meeting, after you (Pointing at Mayor Jones) finished all of your business for the day and for the City. I am requesting that he put you under citizens' arrest on my behalf doesn't mean you've gotta be locked up doesn't mean you've gotta be put into a jail cell, doesn't mean you have to be hand cuffed, but you're going to turn yourself in and if you don't do it Sir (Pointing to Bailiff) Respectfully, you are violating my rights as a citizen. It's my responsibility and my liability will all fall upon me and I don't have to prove you guilty for what? One for committing perjury during your depositions, perjury when you said you didn't break conflict of interest laws about the FPPC just cause the FPPC didn't prosecute you, these people don't know the FPPC can't prosecute anybody they have to call the DA's they're not going to call the DA's my timers going here's what I got to say Mr. Jones turn yourself in for citizens arrest, you (Pointing at Bailiff) go ahead and take him for it. If it doesn't I'm going to call the National Guard next and if that doesn't work I am going to ensemble what is called the Badger Flats Militia for the peaceful transition for the turning over of the Government of California to Federal Authorities and for my brother here Carl Galloway here's what he says and my brothers you look here you look here folks and you see who I am with these black people they would say Sir you know what we call you sitting around with a bunch of boys you're a one lying nigger and that comes from me. You go ahead and hiss all you want that's what it is if that doesn't hit national TV from Chanel 47 cause will see why nobody want to have me going to court with you guys cause I'm going to take all you guys down.
