Re: Merced County Cabal/Request Assistance and Response to this email

Hello Greg and Patrick,

Do you know each other by any chance? If not let me introduce the two of you with this email. Now, please try to be honest here with your answer to this next question Greg.

Did you speak to Pat prior to your speaking to me this afternoon (September 10th, 2012)? Please inform me if you did.

Basically, Pat, Greg says that if you have committed any crimes of obstructing justice (assisting by ignoring what DA Morse is obstructing), or abuses under the color of law, you're o.k. by him because you are out of his jurisdiction. Greg made no comment about the destroyed citizens complaint or the report of a felony police report by Deputy Scott that Warren Yates reported to the Merced DA (you Pat) that they are not even acknowledging they received.

Essentially, I want them to make a decision that it is either Morse and his boys asses in a sling or theirs for joining in to cover up the assault upon me.


Therefore, if you don't do something about this you are in on it with them. They have already suckered you (Greg) into thinking you were going to B.S. your way with me. It did not work.
