Re: Department of Justice/Obstruction of Justice by Law Enforcement/Your Conflict, but still your duty.

Dear District Attorney Morse:

I write this letter in response to your phone message left me on Thursday, August 13th, 2009. Even though I appreciate your tendered apology of not getting back to me the prior week as promised, I sincerely do not appreciate what appears to be a lack of candor by dodging the real crux of the issue. Your seemingly ignoring the obvious necessitates me authoring a somewhat lengthy letter pointing out what you are trying to coyly ignore.

I am the victim of a repeat crime by law enforcement agencies of Merced County which include the Merced County Sheriff's Department, Los Banos Police Department and the California Highway Patrol. The latest attack upon my person was by none other than Merced County Deputy John Picinich that caused me to be hospitalized from his slamming my head against a solid wood door after being handcuffed behind my back. The incident would have been captured on two recorders had it not been for the tampering of exculpatory evidence at the scene of my arrest by law enforcement officers.

As I type, I have reason to believe, based upon tangible evidence, that complaints filed by me against the law enforcement agencies who are now "investigating themselves" are spawning a flurry of activity resulting in the continued obstruction of justice, i.e., everyone getting their stories together while I am denied equal protection under the law.



You were provided the opportunity to listen to the digital recordings in my possession (and bring along Merced County Sheriff Mark Pazin) which would substantiate that I was the victim of false arrest, police brutality, and the obstruction of justice by the Merced County Sheriff's Department, The Los Banos Police Department, and the California Highway Patrol.

Your call was to inform me of your efforts to arrange a meeting between yourself, me, and Sheriff Pazin to hear the recordings. Your message didn't mention a word about it. It is obvious you don't want to listen to them to insulate yourself from the cabal. By the way, I also took your repeated suggestion and left a second message for Mark to give me a call. It has not been returned.

Your message to me said absolutely nothing and blatantly ignored addressing any of the issues concerning my being denied due process, equal protection under the law, and your inability to either investigate, or prosecute Picinich, et al. or Mr. Corey Pride, or Mayor Jones. The same conflict goes double for Sheriff Pazin.

Both you and he having such conflict does not negate your responsibility as law enforcement officers to immediately get the right Federal law enforcement agents in contact with me for my protection and equal protection under the law.

You bemoaning your conflict to investigate cases having to do with the prosecution of me are sheer clap trap. As you know; you have no cases to prosecute against me because I did nothing wrong. Do you really think people are going to believe that the courthouse surveillance cameras which would have recorded the incident of Picinich's first assault upon me in February weren't operating that day? Come on!

You informed me that you were in contact with Mr. Dane Gillette of the Attorney General's Office. I had already told you that the Attorney General's Office would have a conflict, and you in fact had already told me that the AG's Office would not have anything to do with the investigation or the prosecution of any case if charges were brought against me.



Therefore, you are knowingly running yourself and more importantly, me and my intangible rights to equal protection, due process, and honest services into a dead end.

Ex-Attorney General Bill Lockyer along with his lead henchmen, Deputy AG Paul Hammerness are at the epicenter of the problem that now needs to be addressed. It was Hammerness that filed the nefarious Motion to declare me a Vexatious litigant for Lockyer personally. The AG's office has a bigger conflict in handling any cases against me than you do.

It was the attorneys for Tetra Tech who opened up Pandora's Box when they Requested Judicial Notice of the unfounded and DENIED Motion to Declare me a Vexatious Litigant in the case you are a named but still un-served defendant. I assert that it was far more than attorney negligence, but their perpetrating a fraud upon the court while trying to prejudice me before the court. Also, for the record, the request for judicial notice was denied.

However, their plan to prejudice me worked. Mr. James Padron, when not a judge on the case or even a pro-tem judge for the case management conference, decided he was going to cut me (who he wrongfully perceived as a gadfly) out of the legal process and obstruct justice. There is no immunity for Padron's actions when he clearly had no jurisdiction in the case.

In Merced County, which includes of course Atwater and Los Banos, the leading newspaper, McClatchy Newspapers, is reporting that I am a known racist (which I am not)...but not reporting that I have a lawsuit against African American Mayor Tommy Jones for saying that he knew for a fact that I was a member of the Ku Klux Klan and dangerous.

The NAACP demanded Atwater Councilman Gary Frago to resign for forwarding emails that had racist jokes in them. The NAACP contends that his position as a public official required a higher standard of concern for partaking in racist comments.

When Los Banos City Councilman Tom Faria said that he was in contact with members of the NAACP for guidance in drafting a public condemnation of my actions and my using the "N" word, I sent a package to Mr. Jon Grissom of the Los Banos NAACP. I requested the NAACP to review my speech, my background, and my writing, and to issue a finding that I was not a racist according to NAACP definitions.

I also requested that the NAACP publicly reprimand Jones and use the same scales of justice for his attack upon me due to my reporting upon his arrest for possession of crack cocaine when a city councilman and my filing the FPPC complaint and breaking the news of the undisclosed loans he had from Ranchwood Homes Developer, Greg Hostetler.



The package was accepted at their P.O. Box then refused and returned back to me. Undaunted, I spoke at the Atwater City Council meeting to the gasps from the audience when they heard of my ordeal under the assault of Jones and Corey Pride of the Los Banos Enterprise/McClatchy Newspapers. I will also say it was refreshing to hear the applause at the end. I don't think anyone in the room doubted that Jones should be scrutinized as severely, if not more than Frago.

The assault which is aimed at drumming up public hatred of me, which increases the risk of harm to me and family, has been supported by law enforcement agencies and public officials that quite frankly would rather see me dead than alive.

They certainly want me unjustly hated by the public, for if I am, the public will not take action and will not believe the evidence I have against the public officials and media that is manipulating public sentiment.

It is a Dante's Inferno for a corrupt government which brings to mind the most recent assault upon my character to the public.

The August 14th, 2009 LBE article by Corey Pride "Prayer at meetings questioned" refers to a "citizen." According to Reverend Hammond, the City Planning Commissioner, "The problem is created by one person, and that person didn't cause it for religious reasons. He caused it to cause a problem."

It is obvious to those that watched either the Los Banos city council meetings or had a soda at Los Banos Drugs that I am that person. Pride has told members of the Recall of Jones 2009 that I am a known racist...but I repeat myself to you. You have been copied most of the letters, if not all of the letters justifying your action to help me immediately.

Pride's bad actions have been ratified by law enforcement to the public when they did not arrest Pride for battering and assaulting me on camera. Pride said he hit me to get my attention. What if he hit me with a knife in his hand to get my attention?

LBDP refused to do a civil standby at the courthouse next door the day after I was assaulted by Deputy Picinich to insure the peace when we went to film and found out at the last moment that Picinich was going to be there. Is the LBDP rolling in to protect Officer Parker who is a subject of the complaint?

With the above said, I am not willing to play the game of telling you things about elements of this case that you should already be aware of and therefore simply refer you to the case of Forte vs. Knight Ridder, et al. C06-03948-JW for review.

You opined that you were going to be calling AG Jerry Brown if you didn't get some resolution to the matter ASAP.

Larry, you need to contact him now, and start to arrange a meeting between myself, you, Mr. Marion Santos, Mr. Bill Lockyer, Mr. Leon Panetta and President Barack Obama. I am a former candidate for Governor of California who ran on the platform of exposing the poster child of media supported, public official, and judicial corruption.

I am under attack by those close to Panetta from Monterey County who are on the verge of being exposed.
