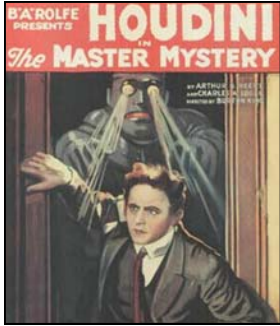

The August 31st, 2009, LBE website version has the
sentences,

"The incident comes nearly three months after Jones was
referred to as a lying N-word at the June 3 City Council meeting.
Anyone with information about this crime is encouraged to call
the police department's anonymous tip line at 827-7070 ext. 288."

After my conversation with City Attorney Vaughn on Thursday,
September 3rd, 2009, notifying him of my intent to sue the City of
Los Banos for permitting Mayor Jones and city officials to conspire
with McClatchy Newspapers to defame me, the article, as it
appeared in the printed edition the following day on Friday,
September 4th, 2009, *DID NOT HAVE* the sentences,

"The incident comes nearly three months after Jones was
referred to as a lying N-word at the June 3 City Council meeting.
Anyone with information about this crime is encouraged to call
the police department's anonymous tip line at 827-7070 ext. 288."

The deletion of the sentences was done at the direction of yet
unknown city officials, such as Mayor Jones or his attorney, Mr.
Benjamin Ratliff, in conversations with yet unknown persons at
McClatchy Newspapers, or their representatives, Levy, Ram &
Olson.

It is prima facie evidence that the newspapers are controlled by
the government, and in my case, being directed to defame me in
